## MEMBERSHIP STATUS CHANGE

The Pastor and Elders shall examine the membership roll periodically to evaluate the necessity of membership status changes. The procedure for changing membership status shall be as follows:

1. Absence: Any member who indicates a lack of interest in the ministry of the church for a period of one year or does not respond to written inquiry from the Elders shall have his membership terminated by the Elders. Written notice of said termination shall be sent to the individual.
2. Discipline: Any member who is found guilty of conduct unbecoming a Christian and refuses to respond appropriately to discipline as outlined above shall have his membership terminated. The Elders, after due consideration and prayer, shall decide such termination. The reason for the termination shall be stated in a pastoral letter to the terminated member.
3. Voluntary Termination: Any member may voluntarily withdraw his membership by making written request to the church office.

## CHURCH DISCIPLINE

In the event of persistent unrepentant sin, it will be necessary to counsel and restore the sinning Church member. If satisfactory resolution does not occur, the Elders shall carry out the commands of our Lord as set forth in Matthew 18:15-17. The final step in this action, if necessary, will be the presentation of the individual to the Congregation for their prayer and counsel. If it is necessary after this, the Elders will remove the member from the church rolls. I have read and understand the above items in the By-Laws concerning membership responsibilities and agree by God's grace to fulfill them.

5 **BY-LAWS**

6 (revised October, 2011)

7  
8 **PREAMBLE**  
9

10 We, as a people who have come together to form a local church for the purpose of bringing glory to  
11 our Lord Jesus Christ, do now set forth these By-Laws as an instrument of guidance in knowing and  
12 doing the will of God for the government of His Church. Working in concert with the Constitution of  
13 the Church and the spiritual leadership, it is our desire that these guidelines will provide a framework  
14 whereby individuals within the Body of Christ may be strengthened in their walk with the Lord. We  
15 have as one of our primary goals, the maintenance of a spirit of unity among ourselves as believers in  
16 order to bring glory to our Lord. We dedicate these By-Laws to this end. (Psalm 133)

21 **Article I**

22 **MEMBERSHIP**  
23

24 **QUALIFICATIONS**

25 Any person desiring membership in this Church shall meet the requirements for faith and conduct  
26 set forth in Article V of the Constitution of the Cornerstone Evangelical Free Church of Prescott.  
27  
28  
29

30 **ADMISSION**  
31

32 Prospective members shall apply for membership by preparing and submitting a membership  
33 application form. Each applicant for membership shall be a self-professed follower of Jesus Christ  
34 committed to living according to the standards set forth in the Scriptures. Each applicant shall  
35 complete an appropriate class as determined by the Elders. Selected Elders or those whom the  
36 Elders designate shall hear the applicant's personal testimony of faith in Christ and of their present  
37 relationship with Christ. The names of applicants shall be made available to the membership of  
38 Cornerstone Evangelical Free Church at least one week prior to the Elder's decision on membership.  
39 Applicants shall be accepted into membership upon confirmation by a vote of the Elders. Following  
40 this vote of approval by the Elders, new members will be welcomed into the Church and presented  
41 to the congregation at a subsequent worship service. Pastoral staff and their spouses shall be  
42 accepted into membership when they begin their ministries with the church.

123 The Pastor and Elders shall examine the membership roll periodically to evaluate the necessity of  
124 membership status changes. The procedure for changing membership status shall be as follows:  
125 1. Absence: Any member who indicates a lack of interest in the ministry of the church for a period of  
126 one year or does not respond to written inquiry from the Elders shall have his membership

140 Church member. If satisfactory resolution does not occur, the Elders shall carry out the commands of  
141 our Lord as set forth in Matthew 18:15-17. The final step in this action, if necessary, will be the  
142 presentation of the individual to the Congregation for their prayer and counsel. If it is necessary after  
143 this, the Elders will remove the member from the church rolls.  
144

## 146 **ARTICLE II**

### 147 **CHURCH GOVERNMENT**

148  
149  
150  
151 Since this Church uses a congregational form of government, it is the responsibility of the  
152 Congregation to put in leadership positions those men who have been gifted by the Holy Spirit to  
153 provide leadership for the Church.  
154

155 Once they have been elected these men, known as Elders, will provide leadership for the total  
156 Church program.  
157

158 To them are committed the responsibilities of being examples to the flock, giving the church  
159 direction, teaching the people, and leading the Congregation. Scripture implies that individuals at  
160 any level of leadership involved in decision-making as it relates to Church policy or doctrine shall be  
161 under the Elders' authority. All church officers and committee chairs shall be members in good  
162 standing of the Cornerstone Evangelical Free Church of Prescott.  
163  
164

## 169 **SECTION A** 170 **PASTORAL STAFF**

171 The Pastor(s), with the Elders, shall be responsible to “shepherd the flock of God” and give spiritual  
172 leadership to the congregation of Cornerstone Evangelical Free Church. This should be  
173 accomplished through the study, preaching and teaching of the Word of God and setting an  
174 example for the flock. They will also promote and lead the church in its central purposes of  
175 evangelism, fellowship, discipleship, ministry and worship.

176 A Pastor must be a man of true Christian character, sound in the faith and doctrine, and qualified to  
177 preach and teach the Word of God (II Timothy 3:17, II Timothy 4:1-5) and shall fulfill the qualifications  
178 of an Elder.  
179

### 180 **SENIOR PASTOR**

181 The Senior Pastor shall give leadership to the Elders and the congregation as Pastor-Teacher. He  
182 shall give primary attention to the *“equipping of the saints for the work of ministry, for the edifying (or*  
183 *building up) of the body of Christ” (Ephesians 4:12).*

184 1. The Senior Pastor shall be a voting member of the Elders.

185 2. He is accountable to the Elders and the congregation. The Elders shall evaluate his performance  
186 periodically.  
187

### 188 **CALLING OF A SENIOR PASTOR**

189 When a vacancy occurs, the Elders shall make temporary provisions for filling the pulpit during the  
190 vacancy, and shall activate a Pastoral Search Committee. The Pastoral Search Committee shall  
191 recommend one or more candidates to the Elders. The Elders shall consider the candidate(s) and  
192 recommend an approved candidate to the congregation. A call to the candidate shall consist of a  
193 favorable vote by at least seventy-five percent of the voting members present at a congregational  
194 business meeting held within seven days after the presentation of the candidate to the  
195 congregation. The vote shall be by secret ballot. He shall be called for an indefinite period of time.  
196 For the termination of his ministry, two months notice must be given by the Pastor, or by the church,  
197 unless waived by mutual consent of both the congregation and the Pastor. This consent by the  
198 congregation requires approval of 75% of the members present and voting.  
199

### 200 **PASTORAL DISCIPLINE**

201 Discipline or removal of the Senior Pastor shall be in accord with the procedures set forth in Article II  
202 Section C concerning discipline or removal of an Elder. If dismissal of the Pastor is the result, the  
203 Elders must give a notice to the Pastor in writing thirty days in advance of the date of termination  
204 unless modified by mutually satisfactory arrangements. The Pastor shall be dismissed by a seventy-  
205 five percent vote of all members present at the special business meeting. In the event of resignation  
206 or dismissal of a Pastor, a two-month severance pay amount will be given unless the Elders modify  
207 this amount. Any severance pay amount greater than two months shall be approved by the  
208 membership.  
209

### 210 **OTHER PASTORAL STAFF**

211 The church may add additional pastoral staff to meet the needs of pastoral leadership and care as the  
212 congregation grows. The Elders will determine the process for adding additional pastoral staff.

213 1. Other pastoral staff shall work with and be a voting member of any committee as outlined in  
214 their job description, or as delegated by the Senior Pastor or the Elders.  
215

216 2. They shall be accountable to the Elders and report directly to the Senior Pastor. Their  
217 performance shall be evaluated regularly by the Senior Pastor.  
218

219 3. They shall be called for an indefinite period and may be terminated by action of the Elders.  
220  
221

226  
227 **SECTION B**  
228 **NON-PASTORAL STAFF**  
229

230 Non-pastoral staff includes any paid employee other than Pastors. Job descriptions shall be  
231 maintained and include qualifications and responsibilities.  
232

- 233 1. All non-pastoral staff shall be hired by the Senior Pastor with the approval of the Elders. Pay and  
234 benefits shall be set at the time of employment by the Elders.  
235  
236 2. Supervision and regular evaluation of non-pastoral staff shall be determined by the Senior Pastor  
237 based on the nature of the position.  
238  
239 3. Employment of non-pastoral staff is for an indefinite period. Resignations and terminations shall  
240 be acted upon by the Elders.

241 **SECTION C**  
242 **ELDERS**  
243

244 The Elders shall consist of the Senior Pastor and at least three men elected by the congregation.  
245 The number of elected Elders may be increased or decreased from time to time by the Congregation  
246 on recommendation from the Elders without amendment to the By-Laws. The number of Elders shall  
247 never be less than four. (Articles of Incorporation, Section 9).  
248

249 The Elders shall lead in the spiritual oversight of the Church, aiding in and providing direction for  
250 matters related to worship, visitation, church discipline, Christian education, evangelism, pastoral  
251 ministry, and church unity. (Acts 20:28 and Ephesians 4:3)  
252

253 The Elders may, at their discretion, place one Elder on any committee of the church. He shall have  
254 full voting rights.  
255

256 **ELDER QUALIFICATIONS**  
257

258 Men who have been equipped and gifted by the Holy Spirit with the qualifications found in I Timothy  
259 3 and Titus 1 will be eligible for election as an Elder. These men will also fulfill the responsibilities and  
260 duties of church members as set forth in Article 280 I.  
261

262 **ELECTION AND TERM OF OFFICE**  
263

264 Nominees for Elder shall be selected by the nominating committee and approved by the Elders.  
265 These nominees shall then be presented to the congregation for approval and voting thereon. A call  
266 as an Elder shall consist of a favorable vote by at least seventy-five percent of the members present  
267 and voting.  
268

269 The term of office shall be for one year. An Elder may succeed himself providing that he recognizes  
270 that his service has been within the will of God, and in addition, the nominating committee must  
271 concur.  
272

273 Accusations against an Elder shall not be considered unless supported by two or more witnesses. (I  
274 Timothy 5:19-20). Should it be proven that he has erred in doctrine or conduct, he shall be  
275 admonished in the spirit of love by the other Elders. If this does not achieve the desired effect, he  
276 shall be temporarily relieved of his post as an Elder (or as Pastor if he is the Elder in question) and the  
277 matter shall be brought to the attention of the congregation at a properly called business meeting.  
278  
279  
280

285 The Elders shall choose officers annually, a Chairman and Secretary. The responsibility of the  
286 Chairman shall be to organize and facilitate the activities of the Elders and to preside at all  
287 congregational meetings. The Secretary shall keep the minutes of all Elders and Congregational  
288 meetings and be responsible for the necessary Elders records and correspondence. The Secretary of  
289 the Elders shall also function as the Corporate Secretary for all legal functions.  
290

291 The Pastor shall not serve as Chairman of the Elders at any time.  
292

## 293 **SECTION D**

### 294 **STANDING OFFICES**

295  
296  
297  
298 The officers of this congregation shall be the Senior Pastor, the Elders (see Article II, Section C), the  
299 Treasurer, and the Financial Secretary.  
300

#### 301 **TREASURER**

302  
303 The term of office is one year and is not limited in terms of consecutive terms. The Treasurer shall  
304 have the following duties:  
305

- 306 1. Be responsible for the disbursement and payment of all bills.
- 307 2. Keep adequate records of all receipts and disbursements by account.
- 308 3. Submit a monthly report to the Elders.
- 309 4. Submit financial records for audit as directed.  
310

#### 311 **FINANCIAL SECRETARY**

312  
313 The term of office is one year and is not limited in terms of consecutive terms. The Financial  
314 Secretary shall have the following duties:  
315

- 316 1. Keep a detailed report of all funds received by the Church.
- 317 2. Deposit and receipt all monies given to the Church.
- 318 3. Submit reports to the Treasurer.
- 319 4. Submit financial records for audit as directed.  
320

## 321 **ARTICLE III**

### 322 **COMMITTEES**

#### 323 **SECTION A**

#### 324 **PERMANENT COMMITTEES**

325  
326  
327  
328  
329  
330  
331  
332 Chairmen of all permanent committees shall be elected for one year and be eligible 348 for  
333 successive terms. All committees shall report to the Elders.  
334

##### 335 **1. The Nominating Committee**

336  
337  
338  
339 This committee shall be composed of at least four members; the Pastor, one Elder, and additional  
340 members chosen at large from the congregation and elected by the Church membership at the

345 annual meeting. Quorums for all committee meetings shall be at least one-half of the committee  
346 membership. The nominating committee is to prepare a list of candidates for all elective offices and  
347 standing committee chairpersons to be submitted to the Elders for approval. Approved candidates  
348 are to then be presented to the congregation to be voted on.  
349

## 350 **2. Missions Committee**

351  
352 This Committee shall have the responsibility of providing direction for the church family regarding  
353 missions activities under the overall direction of the Elders.  
354

### 355 356 **SECTION B**

#### 357 358 **TEMPORARY COMMITTEES**

359  
360 From time to time, special committees may be formed by the Elders for specific purposes and time  
361 periods. These committees will report to the Elders as requested. Examples of ad hoc committees  
362 are those for building, pulpit, audit and social; there may be others. The chairpersons and  
363 membership of such committees shall be appointed by the Elders.  
364

### 365 366 367 368 **ARTICLE IV**

#### 369 370 **CONGREGATIONAL MEETINGS**

##### 371 372 373 **SECTION A**

#### 374 375 **BUSINESS MEETINGS**

376  
377 The annual business meeting of the Church shall be held during the month of January. Annual reports  
378 shall be received, elections held, and other business may be transacted at the annual meeting. The  
379 fiscal and business year shall end on December 31.

380 One-quarter of the voting membership shall constitute a quorum for the transaction of all business.

**CONSTITUTION**

**PREAMBLE**

As members of this church, we band ourselves together in order to carry out the commission of our Lord Jesus Christ, and do ordain and establish this Constitution to which we do voluntarily submit ourselves.

Name and Location:

The name of this church shall be the Cornerstone Evangelical Free Church, located in or near Prescott, Arizona.

**ARTICLE II** Purpose:

To love the Lord our God with all our heart, soul, mind, and strength. (Matt. 22:37-39)  
We will manifest this love by:

1. Public worship of God and the proclamation of the Scripture.
2. Nurturing and discipling young people and adults for spiritual growth and service.
3. Supporting and encouraging personal evangelism and missions at home and abroad.
4. Supporting, encouraging, loving and praying for one another.

**ARTICLE III** Affiliation:

The church shall be associated with the Evangelical Free Church of America and its Southwest Border District Conference. It may send delegates to their conferences, support their home and foreign missions, and unite in mutual efforts for the furtherance of the Gospel in whatever measure the church may decide. Such affiliation shall in no way abrogate the autonomy of the local congregation.

**ARTICLE IV** Statement of Faith:

The following statement of faith, adopted at the annual Conference of the Evangelical Free Church of America, June 19, 2019, at Minneapolis, Minnesota, shall be the statement of

faith of the Cornerstone Evangelical Free Church of Prescott, Arizona.

The Evangelical Free Church of America is an association of autonomous churches united around these theological convictions:

### **God**

1. We believe in one God, Creator of all things, holy, infinitely perfect, and eternally existing in a loving unity of three equally divine Persons: the Father, the Son and the Holy Spirit. Having limitless knowledge and sovereign power, God has graciously purposed from eternity to redeem a people for Himself and to make all things new for His own glory.

### **The Bible**

2. We believe that God has spoken in the Scriptures, both Old and New Testaments, through the words of human authors. As the verbally inspired Word of God, the Bible is without error in the original writings, the complete revelation of His will for salvation, and the ultimate authority by which every realm of human knowledge and endeavor should be judged. Therefore, it is to be believed in all that it teaches, obeyed in all that it requires, and trusted in all that it promises.

### **The Human Condition**

3. We believe that God created Adam and Eve in His image, but they sinned when tempted by Satan. In union with Adam, human beings are sinners by nature and by choice, alienated from God, and under His wrath. Only through God's saving work in Jesus Christ can we be rescued, reconciled and renewed.

### **Jesus Christ**

4. We believe that Jesus Christ is God incarnate, fully God and fully man, one Person in two natures. Jesus—Israel's promised Messiah—was conceived through the Holy Spirit and born of the virgin Mary. He lived a sinless life, was crucified under Pontius Pilate, arose bodily from the dead, ascended into heaven and sits at the right hand of God the Father as our High Priest and Advocate.

### **The Work of Christ**

5. We believe that Jesus Christ, as our representative and substitute, shed His blood on the cross as the perfect, all-sufficient sacrifice for our sins. His atoning death and victorious resurrection constitute the only ground for salvation.

### **The Holy Spirit**

6. We believe that the Holy Spirit, in all that He does, glorifies the Lord Jesus Christ. He convicts the world of its guilt. He regenerates sinners, and in Him they are baptized into union with Christ and adopted as heirs in the family of God. He also indwells, illuminates, guides, equips and empowers believers for Christ-like living and service.

### **The Church**

7. We believe that the true church comprises all who have been justified by God's grace through faith alone in Christ alone. They are united by the Holy Spirit in the body of Christ, of which He is the Head. The true church is manifest in local churches, whose membership should be composed only of believers. The Lord Jesus mandated two ordinances, baptism and the Lord's Supper, which visibly and tangibly express the gospel. Though they are not the means of salvation, when celebrated by the church in genuine faith, these ordinances confirm and nourish the believer.

### **Christian Living**

8. We believe that God's justifying grace must not be separated from His sanctifying power and purpose. God commands us to love Him supremely and others sacrificially, and to live out our faith with care for one another, compassion toward the poor and justice for the oppressed. With God's Word, the Spirit's power, and fervent prayer in Christ's name, we are to combat the spiritual forces of evil. In obedience to Christ's commission, we are to make disciples among all people, always bearing witness to the gospel in word and deed.

### **Christ's Return**

9. We believe in the personal, bodily and glorious return of our Lord Jesus Christ. The coming of Christ, at a time known only to God, demands constant expectancy and, as our blessed hope, motivates the believer to godly living, sacrificial service and energetic mission.

### **Response and Eternal Destiny**

10. We believe that God commands everyone everywhere to believe the gospel by turning to Him in repentance and receiving the Lord Jesus Christ. We believe that God will raise the dead bodily and judge the world, assigning the unbeliever to condemnation and eternal conscious punishment and the believer to eternal blessedness and joy with the Lord in the new heaven and the new earth, to the praise of His glorious grace. Amen.

### **ARTICLE V** Membership:

Any person shall be eligible for membership who confesses Christ as Saviour, whose conduct is in accord with his confession, who accepts the Bible as the final authority for his life, and who subscribes to the Constitution and the Statement of Faith of this church. (I Peter 1:22-23, James 1:21-22, Eph. 4:1-6). All applicants shall be reviewed by the Elders according to the by-laws.

### **ARTICLE VI** Property:

1. During the existence of this church, the ownership and control of all property shall remain with the congregation.
2. In the event this church shall ever dissolve, which God forbid, after paying or making provision for the payment of all liabilities of the church, all of the property, real and personal, shall be given to the Southwest Border District, or to any successor Evangelical Free Church District in which this church is located.
3. If a division occurs in the church, the name and all property shall be retained by those adhering to this Constitution and Statement of Faith. In the event of a dispute as to which faction is adhering to this Constitution and Statement of Faith, the Southwest Border District Conference Board shall review the dispute and make a decision binding on both factions.

### **ARTICLE VII** Amendments:

A motion to amend this Constitution may be considered only after it has been presented in writing to the Elders. All amendments will be discussed at a special business meeting 60 days prior to the annual business meeting.

Amendments may be adopted at an annual meeting only with a three-quarter vote of approval of active members present.

**ARTICLE VIII** Corporate Seal and Legal Signature:

The corporate seal of this church shall contain the name of the church with the date and state of incorporation. On all legal documents requiring an official signature for the church, the signature of the chairman or of the statutory agent shall constitute the legal signature.
